



## **Hunting Rules and Guidelines**

1. HeadWaters Land Conservancy reserves the right to deny or revoke hunting permission at its sole discretion.
2. Hunters are responsible for knowing all rules that are specific to the preserve they are hunting.
3. Hunters are responsible for remaining within the preserve boundary. The preserve is surrounded by private property and crossing the boundary is considered trespassing.
4. Hunters consent to video surveillance while on the premises.
5. Hunters must comply with all applicable federal, state, and local hunting laws.
6. Hunters must comply with general preserve rules. Camping, dumping, fires, and trimming or removal of vegetation is prohibited. Motorized vehicles are permitted for hunting purposes only and may only be used on existing roads.
7. The cutting of shooting lanes, or cutting or destruction of brush, trees or other plants for any purpose is prohibited.
8. White-tailed deer hunting is the only permitted hunting on the property.
9. No baiting.
10. No permanent blinds.
11. No trapping.
12. No organized deer drives.



I have read and been informed about the content, requirements, and expectations of the hunting rules and guidelines policy for the Luneack Preserve. I have received a copy of the policy and agree to abide by the hunting guidelines as a condition of permission to hunt at the Luneack Preserve. By completing this application, I agree that my information may be shared only in the context of communication with other hunters and HeadWaters staff.

**Assumption of Risk**

I am voluntarily participating in hunting at the Luneack Nature Preserve. I understand that there are risks associated with my participation in this Activity, such as physical and/or psychological injury, pain, suffering, illness, disfigurement, temporary or permanent disability, death or economic loss. These injuries or outcomes may arise from my own or other’s actions, inactions, or negligence, or the condition of the Activity location (s) or facility (ies). Nonetheless, I assume all risks of my participation in this Activity, whether known or unknown to me, including travel to and from the Activity or any events incidental to this Activity.

**Release and Waiver**

In consideration for being allowed to participate in hunting at the Luneack Nature Preserve, I release from liability and waive my right to pursue litigation against HeadWaters Land Conservancy, their employees, officers, and volunteers from any and all claims, including claims of the Conservancies negligence, resulting in any physical injury, illness (including death) or economic loss I may suffer or which may result from my participation in this Activity, travel to and from the Activity, or any events incidental to this Activity.

I understand that if I have questions, at any time, regarding the hunting rules and guidelines, I will consult with the staff at HeadWaters Land Conservancy.
